Deutsche Bank to see merger by summer if all else fails

DEUTSCHE BANK'S TOP ranks are bracing for a potential government-brokered merger with rival Commerzbank by mid-year as they run out of time to turn Germany's largest bank around.



Executives, preparing to announce results for a difficult fourth quarter on Friday, are concerned such a deal may become their only option if there's no clear improvement in the first three months of 2019, people briefed on their thinking say. The bank has already warned that the final months of last year were impacted by the dramatic images of a police raid in November, which compounded a challenging market environment.

CEO Christian Sewing has pleaded for patience with his current plan, which is centered on cost cuts and efforts to stabilise market share, but talks between the lender and the government have recently intensified. Years of unsuccessful restructurings left the lender with a slump in revenue it has been unable to reverse. That's fanned speculation it will ultimately be forced to merge with Commerzbank in bid to add scale and slash expenses in a notoriously competitive domestic market.

New Unilever CEO inherits disappointing sales performance

UNILEVER REPORTED LOWER-THAN EXPECTED fourth-quarter sales on Thursday, hurt by troubles in Latin America and weak growth in developed markets, showing the challenges facing new Chief Executive Alan Jope.



The maker of Dove soap and Ben & Jerry's ice cream said fourth-quarter underlying sales rose 2.9%. Analysts, on average, were expecting 3.5%, a consensus forecast supplied by the company showed.

Unilever reported full-year sales growth of 3.1% in line with its forecast for growth at the bottom end of its 3 to 5% forecast range. Looking ahead, it said it expects 2019 market conditions to remain challenging and forecast underlying sales growth again in the lower half of a 3 to 5% range, with continued improvement in underlying operating margin and another year of strong free cash flow.
